

The Course is residential and the participants of the Course will be staying in the accommodation provided by the Academy. **The expenditure to be incurred on boarding and lodging of the participants shall be met by the Academy.** However, the expenditure on account of travel of officers for attending the Course may be borne by the respective State/Central Government Department. It is informed that as per SOP of the Academy, those officers against whom any criminal case, DE/PE etc. is in currency or contemplated are not eligible to undergo any training programme/course/seminar/workshop at the Academy. Hence, nominations of eligible officers may only be sent accordingly.
