6. Dress Code for Indoor Sessions:





5. The Course is residential and the participants of the Course will be staying in the accommodation provided by the Academy. **The expenditure to be incurred on boarding and lodging of the participants shall be met by the Academy.** However, the expenditure on account of travel of officers for attending the Course may be borne by the respective state/Central Government Department. It is informed that, as per the Standard Operating Procedure (SOP) of the Academy, officers against whom any criminal case, Departmental Enquiry (DE), Preliminary Enquiry (PE), etc., is pending or contemplated, are **not eligible** to undergo any training programme, course, seminar, or workshop at the Academy. Hence, nominations of eligible officers may only be sent accordingly.
