## CIRCULAR

It is proposed to fill up 01 (one) post of Director General (DG) in the pay matrix Level- 16/17 likely to be available w.e.f. 24.05.2026 in Narcotics Control Bureau (NCB) under the Ministry of Home Affairs on deputation basis. The terms and conditions of deputation will be governed by the Department of Personnel & Training's OM. No. 6/8/2009-Estt. (Pay II) dated 17.06.2010 & OM No. 2/6/2016-Estt.(Pay-II) dated 17.02.2016 as amended from time to time. Selected candidate will be appointed to relevant pay level of 16 or 17 depending on the level of post being held by such officer in the parent cadre and as approved by the Competent Authority.
