**JOINING INSTRUCTIONS FOR PHYSICAL COURSES**

1. **Working Days & Hours:** Monday to Friday - From 09.15 AM to 06:00 PM
2. **Eligibility:** Officers of the rank of **SP to ASI**
3. **Location:** CDTI, Hyderabad is located at Ramanthapur, between Hyderabad Public School and Doordarshan Kendra (Hyderabad), at a distance of about 10 kms from Hyderabad/Secunderabad Railway stations. The Hostel is situated within the Institute Campus. City buses, auto-rikshaws and taxis ply from Hyderabad/Secunderabad/Kacheguda/Charlapalli Railway stations.

4. **Administration:** On reporting at CDTI, Hyderabad trainee will have to find out the room allotted to him/her from the Hostel Reception and occupy the same. During the period of training, no leave will be granted. It will not be possible to spare the trainees for Court work during the training period. Trainees should finish their evidence in Courts before leaving for CDTI training or seek suitable adjournments. Trainees should not bring any service or private weapons and ammunition. Sports facilities such as Basket Ball court, Volley Ball court, Table Tennis, Gymnasium, and Badminton are available in the campus. Yoga hall is available in the training block and Yoga timings are 7 to 8 AM. Trainees to bring suitable dress for Yoga practice and also for sports of their choice.
5. **Dress:** All the trainees will bring with them the uniform of their rank. The trainees will wear their prescribed Uniform in the Inauguration and Valediction. For remaining sessions, Smart Civvies (Formal Pants, Full/Half Shirt and Tie (Optional) for Men and Saree/Salwar/Shirt Pant for Women. Chappals, Sandals, Jeans and Sports Shoes will not be allowed in the class room. If necessary, uniform should be worn during visits.
6. **Mess:** The training programme is residential. The Hostel Mess provides both vegetarian and non-vegetarian meals. Each trainee will be provided with a cot, mattress, pillow, table and a chair in the Hostel. A Washerman has been provided in the Hostel at approved rates. He is the only authorized person to enter the Hostel premises for collection and return of clothes after wash. Officers are required to wear proper dress while coming to the lunch/dinner and should not put on Chappals, Night Suits, Lungi, half pants etc. in the mess.
7. **Course Time-table:** Course Time-table will be provided in the Course WhatsApp Group well in advance. CDTI, Hyderabad has a well-stocked library with spacious reading room. The participants can avail this facility.
8. Family accommodation, if required, would be provided as per the availability of rooms. Prior approval should be taken before bringing families.
