SPECIFICATION OF KIT BAG MINERAL KHAKI WITH COTTON ROPE (1956)

<u>Material and Finish:</u>- The bags shall be made of duck Cotton Mineral Khaki IS: 1422- 1983 (Third Revision) reaffirmed 2000 amendments no. 3- variety no. 2 with latest amendment if any. The Bags shall be designed according to the sealed and approved sample available at U.P. Police Central Store, Kanpur.

<u>Manufacture:</u> The bag is to be made of two pieces of duck cotton. One piece forming the side and other forming the bottom. Bottom must be made of two circular pieces of 40.6 cm diameter sewn together concentrically not more then 5.1 cm a part.

<u>Stitching:-</u> The two ends of the cloth forming the body should overlap each other 1.9cm the raw edge being turned 0.6 cm inside and securely stitched by double row of stitches. The side piece and the bottom are to be stitched together by two rows of seams the overlapping being 1.3 cm. The top edge of sides or mouth shall be hemmed with a inside turning of 5.1 cm. The seams must be 0.5 cm. from the raw edge.

<u>Flap:-</u> A Flap of 22.9 cm diam. at 15.2 cm distance from its neck should be securely stitched to the top hem. 1.9 cm neck should be inside the top hem stitch. Total length of the flap being 26.7 cm measured from the hem edge. The raw edge of the flap shall be turned 1.3 cm inside. width at neck, being 8.9 cm. The neck of the flap should be stitched to the top hem centrally with the side seam which in turn should be centrally between two eyelets.

<u>Rope:-</u> It shall be a cotton rope one of its end should be fastened in the spliced loop form to one of the eyelets Closer to side seam of the bag. The loop shall be 3.1 cm long with firmly. Splicing. The rope shall be 254 cm long and 0.6 cm diam. made of 4 stands. The free and shall be firmly tied with the sewing thread.
