Subject:- Filling up of the post of **Deputy Director of Enforcement** in the Directorate of Enforcement, on deputation basis- regarding.

The undersigned is directed to say that it has been decided to fill up 95 posts of **Deputy Director of Enforcement** in PB-3 of Rs. 15600-39100 with Grade Pay of Rs. 6600, on deputation basis in the Directorate of Enforcement at Delhi, Mumbai, Chennai, Kolkata, Chandigarh, Jaipur, Lucknow, Patna, Jalandhar, Srinagar, Bangalore, Cochin, Hyderabad, Guwahati, Ahmedabad, Goa, Madurai, Calicut, Bhubaneshwar, Raipur, Surat, Indore, Nagpur, Bhopal, Dehradun, Jammu, Shimla, Allahabad, Ranchi, Mangalore, Vishakhapatnam, Gangtok, Agartala, Kohima, Aizawl, Shillong, Imphal and Itanagar.

2. The following categories of officers are eligible:-

Officers of All India Services or Central Services including State Governments, State Police Organisations or Central Bureau of Investigation or Reserve Bank of India or Public Sector Banks:

(A) (I) holding analogous post on regular basis in the parent cadre or department;  
or

(II) with five years' service in the grade rendered after appointment thereto on a regular basis in Pay Band-2 of Rs. 9300-34800 plus Grade Pay of Rs. 5400 or Pay Band-3 Rs. 15600-39100 plus Grade Pay of Rs. 5400 or equivalent in the parent cadre or Department; and

(I) possessing experience of at least five years in the field of Legal work, intelligence, investigation work and Adjudication or prosecution relating to fiscal or criminal laws; or

(II) possessing investigative experience of at least five years in Banking or Accounts or Audit.

NOTE-1:- For RBI Officers: Group 'C' (Assistant General Manager) or Group 'D' (Deputy General Manager) would be considered in the field of deputation.

For Public Sector Banks: Scale IV(Chief Manager) or Scale-V (Assistant General Manager) would be considered in the field of deputation.

The Departmental officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, deputationist shall not be eligible for consideration for appointment by promotion.

(Period of deputation (including short term contract) including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization or department of the Central Government shall ordinarily not exceed four years. The maximum age limit for appointment by deputation (including short term contract) shall be not exceeding 56 years as on the closing date of receipt of applications).

NOTE-2:- For the purpose of appointment on deputation basis, the service rendered on a regular basis by an officer prior to 1<sup>st</sup> January, 2006 (the date from which the revised pay structure based on the Sixth Central Pay Commission recommendations has been extended) shall be deemed to be service rendered in the corresponding grade pay/pay scale extended based on the recommendation of the Pay Commission, except where there has been merger of more than one pre-revised scale of pay/pay scale, and where this benefit will extend only for the post(s) for which that grade pay/pay scale is the normal replacement grade without any upgradation.

3. Deputy Director of Enforcement is expected to be able to coordinate and oversee the intelligence and investigation matters relating to FERA, FEMA and PMLA. However, he/she may be assigned any other function by the Director of Enforcement like review, special investigation and technical work. Therefore, the officer is expected to have an in-depth knowledge of FERA, 1973(since repealed), FEMA, 1999, PMLA, 2002 and other allied Acts and an aptitude for this type of work.

4. The pay & allowances and other terms will be regulated in accordance with the Department of Personnel & Training's O.M/No.6/8/2009-Estt(Pay-II) dated 17<sup>th</sup> June, 2010 as amended from time to time.

5. The Cadre Controlling Authorities are requested that applications of eligible and willing officers may be forwarded in the proforma annexed so as to reach the Under Secretary AD(ED), Ministry of Finance, Deptt. of Revenue, Room No. 55, North Block, New Delhi within 60 days from the publication of this advertisement in Employment News/Rozgar Samachar and the advertisement can also be seen at the Department's website <http://dor.gov.in> and also on the website of Directorate of Enforcement at <http://enforcementdirectorate.gov.in>



6.
