The duration of the course is 11 days.

The training charges shall be borne by MHA/BPR&D while expenditure on travel accommodation etc. will be borne by respective organisation/States/UTs.


(d) Level of Participants/Criteria:

- i) The candidates should be of the rank of Inspector to SP.
- ii) The language of the course will be English and all the course material will be in English.
- iii) The nominated officers should be clear of vigilance angle.
- iv) The basic aim of the course of to impart specialized training to the trainers from different academies so that they may replicate such training in Indian Police Training Academies. Hence, officers with appropriate skills and trainer background may be nominated for the subject course for enhancement of their skills.
- v) The nominated official should be less than <sup>48</sup>~~45~~ years of age and physically fit to undergo the training.
