I am directed to refer to the subject mentioned above and to say that the Government has notified the Public Servants (Furnishing of Information and Annual Return of assets and the limits of Exemption of Assets in Filing Returns) Rules, 2014 under the Lokpal and Lokayuktas Act, 2013 on 14.7.2014. The same is available on DoPT's website at http://persmin.nic.in-DoPT-Lokpal.

As per DoPT's letter number 11017/03/2014-AIS III dated 4th August 2014, AIS officers were hitherto filing annual returns of property under the provision of Rule 16 of AIS (Conduct) Rules, 1968. Proviso to Section 3(2) of Public Servants (Furnishing of Information and Annual Return of assets and the limits of Exemption of Assets in Filing Returns) Rules, 2014, mandates that even those AIS officers who have already filed returns of property under the provisions of the AIS (Conduct) Rules would also मृह काला कारणा be required to file the revised declarations prescribed under the newly formulated उत्Ruiles !!

In terms of Rule 3(2) of Public Servants (Furnishing of Information and Annual Dis Di(K·Ki) Return of assets and the limits of Exemption of Assets in Filing Returns) Rules, 2014, Every public servant is now required to file declaration, information or return, as the case may be, regarding his assets and liabilities as on 31st March every year, to the Competent Authority, on or before the 31st July of that year.

- 6. The above decision of the Government of India may be brought to the notice of all IPS officers and they may be requested to adhere the time schedule indicated in para 3 and 4 above. It is requested that strict compliance to the provisions of Rule 3(2) of Public Servants (Furnishing of Information and Annual Return of assets and the limits of Exemption of Assets in Filing Returns) Rules, 2014, may be ensured.
