ACCORDING TO APPROVED SCHEME OF MID CAREER TRAINING PROGRAMME, IPS OFFICERS WHO ARE IN THE 24 TO 26 YEARS OF SERVICE ARE ELIGIBLE TO UNDERGO PHASE- V TRAINING. AS PER IPS (PAY) RULES, 2007, NO MEMBER OF THE SERVICE SHALL BE ELIGIBLE FOR DRAWING INCREMENT AFTER COMPLETION OF 28 YEARS OF SERVICE UNLESS HE/SHE COMPLETES THE PHASE-V OF THE MANDATORY MID CAREER TRAINING PROGRAMME AS PRESCRIBED BY THE GOVERNMENT OF INDIA. NOW, **DURATION OF PHASE-V MCTP IS THREE WEEKS WITH TWO WEEKS AT SVP NPA, HYDERABAD AND ONE WEEK AT WASHINGTON DC, USA. THE PROGRAMME IS FROM 13.07.2015 TO 24.07.2015 FOR INDIAN MODULE AND FROM 27.07.2015 TO 31.07.2015 FOR FOREIGN COMPONENT AT USA.** MHA VIDE LETTER NO 16011/15/2004-IPS.II DATED 27.08.2010 APPROVED ONE TIME RELAXATION TO THE IPS OFFICERS FOR PHASE V AND DIRECTED THAT IPS OFFICERS OF 1982 AND 1983 BATCHES MAY BE ALLOWED TO DRAW INCREMENTS AFTER 28 YEARS OF SERVICE, PROVIDED THEY COMPLETE PHASE V BY END OF 2011. THE IPS OFFICERS OF 1984, 1985 AND 1986 BATCH HAVE ALSO COMPLETED 28 YEARS OF SERVICE BY 2014. **HENCE, THE FIRST PREFERENCE SHALL BE GIVEN TO THE BACK LOG OFFICERS OF 1982, 1983,1984, 1985 AND 1986 BATCHES . FURTHER, ONLY THOSE OFFICERS MAY BE NOMINATED WHO WOULD BE SPARED BY YOU AND ONCE THEIR NOMINATION IS ACCEPTED, SUBSEQUENT WITHDRAWAL OF NOMINATION WOULD NOT BE PERMITTED.**



AS MAXIMUM NUMBER OF SEATS AVAILABLE IS 88, REQUEST TO NOMINATE ELIGIBLE IPS OFFICERS OF **1982, 1983, 1984, 1985, 1986, 1987, 1988, 1989 AND 1990 BATCHES TO THE SVP NPA LATEST BY 20TH APRIL 2015, REPEAT 20TH APRIL 2015**, ALONGWITH THE COMPLETE CONTACT ADDRESS WITH TELEPHONE / FAX /E-MAIL ID OF THE OFFICERS POSITIVELY.
