Dear Sir,

Please refer to this Ministry's letter of even number dated 17th February, 2015 regarding submission of Annual Immovable Property Return (IPRs) by the IPS officers in the prescribed format.

2. The requisite details in respect of many IPS officers of your State Cadre are still awaited. At present, the different batches of IPS officers are being considered for empanelment to hold various level posts at the Centre for which IPR status is required.

3. In terms of DoPT OM dated 07.09.2011, vigilance clearance shall be denied to an officer if he fails to submit his annual immovable property return of the previous year latest by 31st January of the following year, as required under Government of India decisions under Rule 16 of the AIS (Conduct) Rule, 1968.

I shall therefore be grateful, if you would kindly look into the matter and get the details of IPR-2014 filed by the IPS officers of your state within the stipulated period i.e. by 31.01.2015 forwarded to us at the earliest. Vigilance clearance will be denied in respect of IPS officers who have not submitted their IPR for the year 2014 within the prescribed time limit.
