4. Nominating police Authorities should nominate with appropriate skills and work background who will actually utilize this training as course participants. The Police officials selected for this course should be Inspector General and above. The participants should also have senior members of agency directors of security, National Disaster Management, Deputy Secretary/Director from Ministry of Home Affairs, Chief of any fire Department, medical doctor, Revenue Department and law department. It is also requested to forward the full name (no abbreviation), rank, date/place of birth and current position title and unit of each participant selected for this seminar.
5. No direct application will be entertained.
6. It is requested that nomination of two eligible and willing officers (one main & one reserve) in the rank of IGP and above as per eligibility criteria mentioned in para 4 above may please be forwarded to this Ministry latest by 18th August, 2015 through their respective Home Department/proper channel.
