Sir,

Please refer to the Ministry of Home Affairs letter No.11034/6/2015-IS-VI dated 11<sup>th</sup> September, 2015 forwarding therewith a copy of the minutes of the meeting which was held under the chairmanship of Union Home Secretary on 1.8.2015 to discuss the issue of ISIS/ ISIL phenomenon.

2. As per para 7 (ix) of the minutes of the above meeting, it was noted that investigation of cases relating to terror outfits including the ISIL usually involve sending Letters Rogatory for requests under the Mutual Legal Assistance Treaties. It was further decided that the NIA will organize a training workshop on drafting LR's and MHA will take necessary measures to expedite execution of LR's by foreign countries.

3. In view of above, it is proposed to conduct a one day workshop at NIA HQ, New Delhi on drafting Letters Rogatory in the first week of December, 2015. It is therefore requested that 2 officers (SP/DIG/IG) may please be nominated from your state who are dealing with the subject matter for participating in the above workshop, and their contact details ( Mobile No & email Address) be sent to undersigned by Fax/ email at the earliest. The firm date of the above workshop will be intimated in due course.
