


Dear Sin,

I would like to inform you that this Academy has set up National Digital Crime Resource and Training Centre (NDCRTC) in association with C-DAC, Hyderabad for developing capacity among all State Police and Central Police Organisations by conducting customised training courses on various topics related to Cyber Crime Investigation. NDCRTC has been sanctioned a 2-year "Project" by Department of Electronics and Information Technology (DEITY) under Ministry of Communications and Information Technology (MCIT), Government of India. The primary objective of this Project is to conduct training modules for all the stake holders of Criminal Justice System primarily State Police. The Centre will design and develop its own Course Curriculum as per the Standard Operating Procedure for handling Digital Evidences. During its project period of 2 years, around 2000 officers are going to be trained.

The long term vision of NDCRTC is to develop itself as a "Centre of Excellence" in the field of Cyber Crime Investigation, Digital Forensics and Cyber Security from Law Enforcement perspective. After its project period, this Centre will run as an autonomous institution from NPA premises under overall control of Director, NPA and its governing structure will be decided on its growth in its initial 2-year project period.

NDCRTC started functioning in June, 2015 and has been conducting training to the participants of various Cyber Crime Modules of IPS Probationers as well as In-service Course Participants.
