The LNJN National Institute of Criminology & Forensic Science is organizing the **25<sup>th</sup> P G Diploma Course in Document Examination** from 01/08/2016 to 31 July, 2017.

**Participant level:** SSA/JSA & Freshly recruited scientists in document divisions/State Handwriting Bureau & PSI and above.

**Methodology:** This is a comprehensive course based on the recommendation of the first symposium of Government Examiners of questioned Documents held in 1970 and is intended for fresh recruits in Document Sections of Forensic Science Laboratories, Scientific Sections of the Criminal Investigation Departments and scientists attached in the State Handwriting Bureau. The duration of the Course is 12 months.

**Qualification:** The minimum educational qualification for admission is B.Sc. We can accommodate only ten(10) candidates for this course. It is therefore, requested to nominate one candidate and one reserve from the interested CFSL/FSL/CID(QD) for participation in this Course. You are therefore requested to sponsor suitable officers for this Course and forward their names to us by 09/07/2016, so that acceptance can be communicated to them in time.

**Visits:** As a part of the training, the trainees will be taken to offices of the various Government Examiner of Questioned Documents, Forensic Science Laboratories, ISP/CNP, Nasik and BNP, Dewas, Security Paper Mill at Hoshangabad and Forest Research Institute, Dehradun etc. as well as different courts of law and other places of academic interest throughout country. During the course of training, they will also be attached to the Central/State Document Laboratories for undergoing practical training. As the training entails considerable traveling, the trainees may be provided with sufficient TA advances to enable them to undertake the journeys. The approximate expenditure on study tour works out to be Rs. one lac.

The theoretical part and visits/exposure to the institutions of repute in the file will be covered in 08 months followed by 03 months practical training at their respective laboratory under the guidance of a senior faculty and submit a Laboratory Project Report. In the last one month of the course, the participants will be sent back to NICFS for Tutorials/Seminars and final examination.

**Accommodation:** The Course is non-residential. Limited non family single accommodation may be provided subject to availability to the participants on first cum first serve basis.

No fee will be charged for the Course. The participants attending the Course may draw their TA/DA and Training Expenditure from their parent offices. The participants may kindly be advised **NOT TO LEAVE THEIR HEADQUARTERS WITHOUT RECEIVING JOINING INSTRUCTIONS FROM THIS INSTITUTE.**
